5. The work shall be carried out as per Punjab, PWD specifications latest editions.

7. The bill of quantities for the work is enclosed.
8. The Bidder shall quote its price as at par or percent above or percent below estimated total cost in the bill of quantities as specified there in.

12. Samples strips would need to be compared to the original artworks, in the presence of the photographer until a close match is achieved. Final prints to be printed only after the closet matching of the samples are done.
